EXHIBITOR GUIDELINES

LIABILITY

Neither the Organization nor its agents or representatives will be responsible for any injury, loss, or damage that may occur to the Exhibitor or to the Exhibitor's employees or property from any cause whatsoever. Under no circumstances will the Organization be liable for lost profits or other incidental or consequential damages. The Organization shall not be liable for failure to perform its obligations under this exhibition as a result of strikes, or any other reason beyond its control. Anyone visiting, viewing or otherwise participating in the Exhibitor's exhibit is deemed to be the Invitee or licensee of the Organization. The rights of the Organization under this exhibition shall not be deemed waived except as specifically stated in writing and signed by an authorized officer of the Organization.

INSURANCE

Exhibitors wishing to insure their goods must do so at their own expense.

RESPONSIBILITY OF THE EXHIBITORS

The Exhibitor is responsible for damage to property. No signs or other articles may be attached to walls, doors, etc., in such a manner as to deface or damage them. Likewise, no attachments may be made to the floors by nails, screws, or any other device that would damage or mar them.

Exhibits must be self-contained within the booth area assigned, and no chairs, furniture or exhibit materials are to be placed outside the booth area, nor set up in such a manner as to block any exits. Exhibitors displaying equipment where there is a possibility of oil dripping or other foreign matter must provide an adequate protection to the floor or carpet.

Displays shall not be obtrusive or noisy, nor shall they violate safety codes.

USE OF EXHIBIT

All demonstrations or other promotional activities in the exhibit hall must be confined to the limits of the exhibit booth. Sufficient space must be provided within the exhibit booth for the comfort and safety of persons watching demonstrations and other promotional activities.

Exhibitor shall not assign, sublet, or share the space allotted without the knowledge and written consent of the Organization. Exhibitors must display only the goods manufactured or dealt in by them in their regular course of business. No firm or organization not assigned exhibit space will be permitted to solicit business within the exhibit area.

The Organization reserves the right to restrict exhibits which, because of noise, method of operation, materials, or for any other reason, become objectionable, and also to prohibit or to remove any exhibit which, in the opinion of the Organization, may detract from the general character of the exposition. This reservation includes

persons, things, conduct, printed matter, and anything of a character which the Organization determines is objectionable. In the event of such restriction or removal, the Organization shall not be liable for any refunds or other exhibit expenses. The use of sound systems is permissible, provided that they are not audible into neighboring booths.
